#### **CALL TO ORDER:**

Mayor Senn called the meeting to order and led in the Pledge of Allegiance. Councilman Glasgow gave the invocation.

#### **MINUTES:**

Councilman Goudelock made a motion, seconded by Councilman Boyd to approve the minutes of the regular meeting of Newberry City Council held on February 13, 2018, and minutes from a work session held on February 5, 2018, and a special meeting held on February 23, 2018, as presented. Mayor Senn declared the motion carried following a unanimous vote of City Council members present.

#### **FINANCIAL REPORT:**

Mayor Senn advised that members of City Council had received a copy of the Financial Report and Financial Summary for the period ending February 28, 2018 and noted that the report would be attached to the minutes. City Manager DeWitt gave a brief summary of the financial report.

### **RECOGNITION**

### APPROVAL OF A CONTRACT

## City Manager's Employee Contract

City Manager DeWitt's contract would run for 28 months beginning retroactively on March 1, 2018 and expire on June 30, 2020.

#### **BIDS**

During Open session, Councilman Boyd made a motion, seconded by Councilman Goudelock to allow city staff to begin the bid process for the CPST project as discussed in executive session. The motion was carried by a unanimous vote of the City Council members.
